Max Nunziata appointed as new Salt CEO

Max Nunziata has held several challenging leadership positions in various industries and geographies in both B2C and B2B markets over the last 30 years. Most recently he served as CEO of BonusCard a leading provider of credit and prepaid cards at Cornèr Bank Group. He grew up in Geneva and studied Electrical Engineering with specialization in Telecommunications at the ETH Zurich. He began his career at the European Headquarters of Procter & Gamble in Brussels. He then joined GE Capital where, over a period of 18 years, he held positions in Internal Audit, M&A, Six Sigma, Operations and Sales before becoming CEO of the Italian Leasing and Fleet Management businesses. In 2013, he returned to Switzerland to join the Management Board of Sunrise as Chief Customer Experience Officer and then Chief Business Officer.
