Such fee does not cover the costs for an electrician which might be needed as a result of the move.</p> <p>Should an active Salt Home connection already be available at the new address you are moving to, your contract at the old/former address will be terminated and termination fees limited to CHF 99.95 will be charged to you.</p> <p>Should the services not be available at the new address (proof required, e.g., rental contract), the contract will be terminated and the termination fees limited to CHF 99.95.</p>
Activation delay	<p>Approximately 1 to 7 weeks (and depending on local fiber network provider) for the Salt Fiber Box.</p> <p>Approximately 24 hours for the Salt Gigabox.</p>
Installation of the optical fiber outlet	<p>In most cases, this installation is included in the activation fee.
